



## **Terms & Conditions – Fiper Markets Giveaway Campaign (JETOUR T2 – 2025)**

This document constitutes the official Terms & Conditions for the Fiper promotional campaign. By participating in this campaign, the client explicitly agrees to all the terms stated below.

---

### **1. Organizing Entity**

The campaign is organized and managed by Fiper Markets.  
The company reserves the full right to manage, modify, or cancel the campaign at any time.

---

### **2. Campaign Duration**

The campaign runs from October 1st, 2025 to January 1st, 2026.  
Transactions made outside this period will not be counted, except for qualifying transactions retroactively from March 1st, 2025.

---

### **3. Participation Criteria**

- Only clients with a fully verified real trading account (KYC completed) with Fiper Markets are eligible to participate.
- Coupons are calculated based on net deposits during the campaign period. One coupon is granted for every USD 5,000 in net deposits.
- Deposited funds may be used in any of Fiper Markets' products, including direct trading, copy trading, or managed portfolios, without restriction to a specific product.
- A maximum of 100 coupons per client is allowed to ensure fairness and prevent prize monopolization.

- Financial operations made since March 1st, 2025 are counted retroactively and do not require withdrawal or re-registration.

## 4. Prizes
